 $\cdot$  To differentiate users who are on the same network to enable us to correctly allocate Transactions to the appropriate account.

 $\cdot$  Within research surveys to ensure you are not invited to complete a questionnaire too often or after you have already done so.

### **Third Party cookies**

Third parties serve cookies via this site. These are used for the following purposes:

### Use of web beacons
